<u>What is...</u> Breaking the Chains?

Breaking the Chains (BTC), is a 501(c) 3, Community-Based Organization that provides comprehensive trauma informed residential and non-residential care to adult and juvenile survivors of human-trafficking. BTC also assists with HT advocacy and policy insight. Breaking the Chains will serve the greater Fresno area by collaborating with local law enforcement agencies to combat human-trafficking in the Central San Joaquin Valley.

Our Services

Breaking the Chains serves victims who are trying to break free from human trafficking within our community. We provide the following residential and non-residential services in addition to relocation services that are on a law enforcement referral basis to those in immediate need:

Case Management

We provide both residential and non-residential clients with counseling services, AOD services, and life skills mentoring opportunities with licensed and certified professionals.

Non-Residential

We provide weekly support groups, trauma care, and case management, educational and employment services to all lives impacted by human trafficking.

• Safe House

We provide a 6-bed long-term facility for participants in a secure, confidential location.

ER Services/Shelter/Impact Center

We work with local and national law enforcement to provide participants with a safe, secure, and speedy exit from human trafficking. In most high-risk cases, this can include relocation to another area or immediate confidential shelter services.

• Advocacy:

We advocate on behalf of human-trafficking survivors through community awareness activities and political platforms. We are committed to restoring and rebuilding lives through collaborative community support. Stand with us today!

Expectations:

Support these participants by volunteering your time. We need dedicated individuals who can offer their special gifts and educational backgrounds. Your decision to volunteer here at BTC is appreciated, and we want to make sure that the expectations of your role as a volunteer/employee are clearly defined.

Based upon your designated position within BTC, job duties performed on site include but are not limited to the following:

- Ensure that BTC rules and program guidelines are followed and that there is consistency rather than individual interpretation of the rules.
- Overall community supervision.
- Distribute items to residents as needed.
- Maintain accurate records for all residents, to include remarks on personal and behavioral conduct and overall supervision of residents' conduct.
- Oversee stock and operation of the home.
- Coordinate activities of residents, to include church and group attendance, as well as coordinating special activities.
- Transport residents to various activities.
- Event coordination and execution.
- Event site hosting and table management.
- Technology adaptation and installation.
- Database maintenance.
- Class facilitation.
- Art & therapy related art projects.
- Health & wellness activities.
- Grounds maintenance.
- Facility maintenance.
- Staff support.

Please also keep in mind that these are subject to change and that we are always open to new ideas and areas of expansion. If you have new ideas, please just let us know!



DIRECT SERVICE GUIDELINES

Breaking the chains has set some boundaries and guidelines that will guide volunteers and advocates to know the behaviors and actions that we deem appropriate and inappropriate.

DON'TS

- Outside gifts are discouraged; please see the appropriate case manager first if you have any items that you would like to donate or give specifically to the client.
- No borrowing or loaning.
- > Don't rely on the clients to uphold or set boundaries.
- Don't ask inappropriate questions, this includes questions about their stories as it pertains to their trafficking and/or previous trauma.
- Don't feel the need to answer all of their questions. Sometimes they are inappropriate, and this could cause more harm than help. Please refer them to staff.
- > Don't get easily offended. Personalization is a barrier to connection.
- > Don't be a detective. Inform a staff member if you have concerns.
- > Don't give out your personal information.
- Don't share your personal junk. Remember, they need our help and they cannot process their own junk yet, so they definitely cannot process yours.
- Do not evangelize. These participants are coming from a variety of backgrounds, and we want to be respectful of that. If they would like to know more about your beliefs, please contact staff and we can go from there.

<u>DO'S</u>

- Celebrate their gifts, talents, and successes.
- Keep your commitment to them.
- Know your limits.
- Take this as an opportunity to figure out your own gifts and talents.
- Understand that time is the greatest gift.
- Talk to us about new ideas.
- Promote unity with our vision and with the staff.
- Lead by example. "Their rules are your rules."
- Follow the schedule.
- Embrace "I don't know."

POLICIES & PROCEDURES

CONFIDENTIALITY

Because of the nature of our cliental, we have a zero tolerance confidentiality policy. This means that it is strictly prohibited to discuss any information in regard to our program, safe house, residents, and clients, both current and previous, in any way, shape, form, or fashion outside of current BTC staff members. This includes with other volunteers and individuals who may be associated with BTC. Staff members are listed on the first page of this manual. Additionally, we do not allow any unauthorized photographs or pictures to be taken of our program or clients.

PROHIBITED ITEMS

- No weapons of any kind.
- No outside food or beverages.
- No purses or backpacks. Please lock them in your vehicle.

DRESS CODE

- No provocative apparel
- No strapless shirts

- Shorts must be within 6" of the knee.
- No inappropriate items can be displayed, i.e. alcohol, drugs, foul language, nudity.
- Nothing that can be connected to gang affiliations.
- Any and all apparel is subject to staff approval based on the current temperament of the house.



If an incident occurs, no matter how slight, please see a staff member and fill out an incident report.

All fire exits and emergency equipment are marked and available in case of an emergency.

Please familiarize yourself with the emergency exit plan that is posted and located in each room.

In case of an emergency, please dial 911 immediately. After the appropriate first responders have been contacted, please call Tiffany or Debra 24/7 at 559-492-1566.

YOU ARE BEING WATCHED

There is no expectation of privacy. Our facility is audio and video monitored by the Fresno Police Department and Safeco Security 24/7.

YOUR COMMITMENT

- > They need to know that they can count on you; your word is your bond with them.
- > Accept them for who they are and where they are at.
- > Make sure that your commitment is reasonable and attainable.
- > No Judgement.
- ➤ I can, and I will follow all of the direct service guidelines.
